- **Represent the Requiring Activity during Pre-Award, Award, and Close-Out Phases of the Acquisition Cycle**
- **Administer awarded contracts for the Requiring Activity**

Award –

- **Publish and Distribute the Awarded Contract**



Milestones After Source Selection cont'd

Post-Award –

- **Contract Oversight (with the IARPA PM)**
- **Performance Monitoring**
- **Financial Monitoring**
- **Contract Modification**



Milestones After Source Selection cont'd

Close-Out –

- **Accept Final Deliverables**
- **Process Final Invoice**
- **Past Performance Reports**
