From BAA Section 1.A.1.a, "The ROI represents the analyst's a priori knowledge of the geolocation of the query image/video." Within the program's test and evaluation activities there may be a small number of queries for which the location is outside the ROI, although within the World Region. 015	Is crowd sourcing allowed during fusion?	No. See BAA Section 1.A.5. Topics Not in Scope: "The program is not interested in solutions that crowd source any part of the fusion or query handling processes."	06/30/11

It is up to offerors whether or not operator interaction is used in the fuse process as it is not specified in BAA Section 1.A.1.a or in the notional system described in Figure 1. 020	Who decides whether the camera or a point on an object in the scene should be geolocated? Is this chosen by the analyst when submitting the query or is the system able to select which point should be used?	See BAA Section 1.A.1.a. Prototypes: "The prototype should be able to geolocate either the camera or a point on an object in the scene (that will be specified with the query)." The Government team will specify whether the camera or which object point should be geolocated.	06/30/11

Military educational institutions and employees of military educational institutions are not eligible to compete for funding under an IARPA solicitation. Yes, but any conferences proposed must have a direct benefit to the FINDER program. The query image/video is input to the triage system. See BAA Amendment 01 Section 1.A.1.c. Research Challenges and Analyses. However, it is unclear to us whether this covers development data that we use just in the development phase and not in the evaluations. Could you please clarify?	See BAA Amendment 01 Section 1.A.2.a GFI Reference Data: "The use of additional Reference Data of the same types as the GFI Reference Data is not permitted with the exception of GIS data." 034	Are we permitted to access publicly available datasets of the same type as the GFI Reference Data but for areas outside the World Region.	No. See BAA Amendment 01 Section 1.A.2.a GFI Reference Data: "The use of additional Reference Data of the same types as the GFI Reference Data is not permitted with the exception of GIS data." 035	Is the maximum Analyst Interaction Time in Table 2 specified on a per-query basis?	BAA Section 1.B Program Metrics and Milestones: "Analyst Interaction Time is the total time that the analyst is permitted to spend helping the prototype. Query Response Time is the total wall clock time from when the query is presented to the prototype until the prototype generates its final Candidate List." 036	Is commercially purchased data considered publicly available for the Finder Program?	Yes. Publicly available information includes information available by purchase or subscription. This also includes information that is provided free of cost, upon submission of contact information, such as an email address. No. Contractor and FFRDC employees are already bound by non-disclosure agreements. Offerors may submit a notice of objection to the arrangement. By submission of its proposal, an offeror agrees that its proposal information may be disclosed to employees of these organizations for the limited purpose stated above.
