In a more narrow sense, the term "social goals" can refer to a subset of "social concepts," including intentions; the development and maintenance of relationships; status; politeness; etc. When dealing with social goals, there may be additional factors that you need to take into account, like gender or age or role. These can be explored separately and interdependently. The Program is interested in discovering and evaluating social phenomena broadly. Some of these phenomena will be social goals; some will be other negotiated social phenomena or concepts (e.g., roles, rifts, power); and some will be complex sets of social concepts.</p>	01-06-09
